## **OUR ABILITY AND DUTY TO ACT**

We believe in using the earth's resources wisely and promote this with our business activities and purchases.

Our attention to environmental, social and economic sustainability requires us to be patient and resolute in our business actions, and to demonstrate leadership on the issues that are important to us and our clients.

## **SUSTAINABILITY OBJECTIVES**

In our professional and personal lives, we commit to the following:

#### 1. The efficient use of resources

We will prioritise renewable resource use, and minimise environmental impacts by:

- a) Reduce and reuse paper, and otherwise recycle it. Largely use recycled, FSC accredited paper and timber product supplies.
- b) Compost biodegradable food scraps.
- c) Recycle used batteries.
- d) Use biodegradable laundry and cleaning products.
- e) Minimise water use.
- f) Electricity use: Only turn on lights when required. Do not leave computers running overnight unless required. Enhance natural lighting and solar heating and only use active heating as required. Choose electronic equipment with good environmental credentials and power efficiency ratings.
- g) Travel: Ensure multiple purposes where possible e.g. multiple jobs undertaken; add personal holiday to work trip. When purchasing vehicles ensure they have low CO2 emissions and are fuel efficient. Have video meetings where possible.
- h) Buy locally-produced consumables and food where possible.
- i) Operate under a co-operative model with other consultants who also share our sustainability values and to maximise opportunities, share resources and maintain low overheads and infrastructure.
- j) Keep informed of sustainable business practices through sources such as the Sustainable Business Network.

#### 2. Community Engagement

We will help engage communities towards sustainable practices by volunteering expertise and donating resources to the value of >\$6,000 per annum including free ecological advice and management.

#### 3. Ecological Restoration

We will create approaches to ecological restoration that minimise negative environmental impacts, provide solutions to intractable natural resource-hungry problems, and integrate positive social elements into project outcomes.

#### 4. Carbon off-setting

We have calculated our estimated annual business and personal carbon footprint (electricity, travel, non-recyclable waste). This carbon footprint is offset (several times over) by the estimated carbon sequestration of 11ha of browser-controlled and legally protected regenerating coastal forest owned by the Directors.
